MINUTES OF REGULAR MEETING HELD AT SCOTT CITY HALL THURSDAY, March 6, 2025, AT 6:00 PM

The Mayor and City Council Members met in Regular Session, Thursday, March 6, 2025. Mayor Richard and all council members were present.

Councilman Domingue led the Prayer and Pledge.

Councilman Domingue motioned to accept the minutes from the February 2025, meeting as written. Seconded by Councilman Boudreaux, motion approved.

Councilman Boudreaux motioned to accept the January 2025, Financial Statement. Seconded by Councilman Roy.

Mr. Mark Savoy with Groom's Engineering and Mr. Dustin Guidry, Fenstermaker & Assoc. gave a brief update on on-going projects.

Mayor Richard advertised that Scott Area Team Sports Spring sports registration is now open and the Boudin Festival volunteer opportunities are not posted online.

City Attorney, Mr. Randy Lasseigne swore Mrs. Emilia Pardo as the appointed City Magistrate. Mayor Richard thanked Mrs. Roya Boustany for her service.

Counilman Moreau motioned to adopt Ordinance 2025-3, An ordinance repealing and replacing Chapter 24, Article I. In General Sec. 24-3. Littering of the Scott Municipal Code. Seconded by Councilman Roy, motion carried unanimously.

Councilman Montoucet motioned to adopt Ordinance 2025-4, An ordinance adding Sec. 24-65 of the Scott Municipal Code-Public Nuisances. Seconded by Councilman Domingue, motion carried unanimously.

Councilman Boudreaux motioned to adopt Ordinance 2025-5, An ordinance amending Article II. Fire Prevention Bureau to add SEC. 16-22 (d), SEC 16-22 (e) and SEC. 16-22 (f) of the Scott Municipal Code. Seconded by Councilman Roy, motion carried unanimously.

Councilman Moreau motioned to adopt Resolution 2024-5, A Resolution 2024-5, A Resolution authorizing the disposal of certain movable properties owned by the City of Scott and no longer needed for public purposes. Mayor Richard explained that these items would be sent to auction in April. Seconded by Councilman Roy, motion carried unanimously.

Councilman Montoucet motioned to change the Thursday, April 3rd Council Meeting to Wednesday, April 2nd, 2025, at 6pm. Mayor Richard explained due to the Boudin Festival Grounds being set up for the festival parking for the meeting might be hard to navigate. Seconded by Councilman Domingue, motion carried unanimously.

Councilman Montoucet motioned to grant the request for variance to Mr. Austin Guidry, owner of Gunsmithing, Sales, and Manufacture, AMG Arms, LLC located at 4800 Cameron Street. Mrs. Bonnie Anderson, Comprehensive Planning Facilitator, explained that the Planning Commission unanimously approved with no contingencies. Mayor Richard stated that Mr. Guidry is in compliance with the State and Federal requirements and standards. Mr. Guidry was present for the meeting. No discussion or comments. Seconded by Councilman Boudreaux, motion carried unanimously.

Councilman Boudreaux motioned to approve a request for variance to the Noise Ordinance for a birthday party to Mrs. Kayla Facio from 5pm-12am located at 3708 Landry Road on March 22, 2025. Seconded by Councilman Domingue, motioned carried unanimously.

Councilman Montoucet motioned to approve the change order to the Apollo Road/Lebesque Rd Overlay and Reconstruction Project to include Rue Des Amis up to \$150,000. Mr. Mark Savoy with Groom's Engineering stated that the project came in under budget, adding this road to the scope of the work would save in mobility costs. Seconded by Councilman Domingue, motion carried unanimously.

There being no further business, the meeting adjourned at 6:23 pm.
